Invest in your membership by participating in one (or more!) of the following teams. Build new relationships with fellow NARI members, and add your voice to the association.

Education & Programs: Responsible for securing educational programs and seminars of specific interest to membership. Responsible for monthly meetings and obtaining speakers with topics of interest and importance to the general membership. Oversees certification programming. Committee meets 4 - 5 times a month. Approximately 90 minutes per meeting.

Legislative: Monitors state and local legislative and regulatory agency activity as it pertains to our industry and reports to membership. Monitors and reports activities of Federal Lobbyist. Committee meets as needed. Depends on proposed legislation at the State House.

Membership: Formulates and implements recruitment and retention programs. Committee meets monthly. Approximately 90 minutes per meeting.

Public Relations: Responsible for increasing consumer and industry awareness of NARI. This team also oversees the submittal of entries to NARI National for chapter achievement awards. Committee meets monthly or as needed.

Community Service: Brings appropriate projects of concern before the board for consideration and works through with member involvement. Committee meets as needed.

Events Committee: Plan and implement the Golf Outing, Holiday Party /Awards Gala, implements the Awards Program and Remodelers Night. Can also include other fun events as determined by committee. Committee meets as needed. Each event is a separate task group which reduces time commitment.

Build Remodel & Landscape Expo & Shows: Assists in planning, marketing and staffing of the NARI area of show and any other opportunities available in consumer shows. Committee meets as needed.

Home Improvement Showcase: Assists in planning and implementing the Spring & Fall tours. Committee meets as needed. Usually two times per year.

Corporate Sponsorships: Works as a team to build and recruit Corporate Sponsorships for the organization. Committee meets as needed. 4th quarter and 1st quarter are most important.

Workforce Development: Develop strategies and tactics for increasing short and long-term workforce interest for our industry. Meets quarterly or as needed.
